It is resolved that Red Swastik Society shall run the Project Shivalaya at Village Chaure, Taluka Kalyan, Thane Distt.. The center will be called **Shivalaya**, managed and run by Red Swastik Society, National Headquarter, Mumbai, subject to the following terms and conditions:

# A.Governing and Coordinating Committee (G.C.C.):

The following members of Red Swastik Society shall be the members of GCC, Shivalaya. The G.C.committee shall manage the day-to-day affairs of the Shivalaya. The term of this committee shall be for the period of **5 year (calendar year).**

#### **B.Accounts, its methodology and Funds:**

Separate bank account to be opened and maintained by Shivalaya Center and shall be operated by the following signatories:

- b. Centre Director Dr.Shri.Girish Suryakant Latke,
- c. Coordinator Shri.Mahendra Patel,
- d. Coordinator Shri.Bipin Patel,

(Signature of Centre Director will be compulsory)

- ii. Separate receipts for donation and charges would be issued by the center under the signature of Center Director or by the authority on his behalf.
- iii. Receipts will be printed by the NHQ.
- iv. Center is permitted to collect the funds and create its separate Corpus.
- v. Center will maintain separate books of accounts.
- vi. Periodical and annual a/c will have to be submitted to NHQ.
- vii. Any expenditure above Rs.50,000/-(Fifty Thousand) will reuire the approval of the NHQ, except the monthly salary disbursement.

### C. Command and Control:

- a) This center will function under the direct command and control of NHQ. However, the Centre Director and/or his representative shall handle day-to-day function.
- b) Center will opeate for 24x 7 hours.
- c) The Center Director, as per the convenience, shall decide its timings, in consultation and intimation to NHQ.

### D. Appointment of Adm.Staff:

- a. All the required staff for running the Shivalaya Center will be appointed in consultation and approval of the NHQ
- b.Payment of such staff shall be done from the funds of the Center and it will be on the payroll of the Center.
